

1. INTRODUCTION

1.1

It is with great pleasure that I present my Report on the activities of the National Olympic Committee of Sri Lanka (NOC Sri Lanka) and the Commonwealth Games Association of Sri Lanka (CGA Sri Lanka) for the year 2019. The year 2019 was an eventful one that saw Sri Lanka struggle and suffer through the tragic Easter Sunday attack on the 21st of April 2019. This unfortunate incident severely affected the process of NOC / CGA activities Sri Lanka as well as athletes and the entire sports arena.

Despite all these drawbacks, NOC / CGA Sri Lanka was able to promote Olympism and assist athletes and NFs reach greater heights. Especially, the Women's Committee achieved an important and vital step by establishing a policy for the protection of athlete, keeping in line with the IOC guidelines, for the first time in NOC / CGA Sri Lanka history.

2. STRUCTURE & ORGANISATION

2.2 Meetings

A Special General Meeting was held on 1st June 2019 and the Annual General meeting for the year 2018 was held on 17th December 2019.

An Executive Board meeting was held on a monthly basis. Accordingly, 12 Executive Board meetings were held during the year 2019.

Furthermore, sub-committee meetings were conducted during the year 2019. The Finance Committee rendered a remarkable service by holding its meeting regularly prior to the Executive Board meeting ensuring the systematic of financial operations of NOC / CGA Sri Lanka.

- c. The Media Committee of NOC Sri Lanka continued the publication of the ‘GoodSport’ magazine on a quarterly basis. Accordingly, the Committee executed 4 publications during the year. The Sponsorship & Marketing Committee was able to raise sponsorships as a continued gesture.

At the ANOC Executive Council meeting which was held on 21st of January 2019, Mr. Maxwell de Silva, Secretary General of NOC Sri Lanka was appointed by the ANOC, as a member of its Culture & Education Commission for the period from 2019/2022.

c. Mr. Fazil Hussain, Committee Member of NOC / CGA Sri Lanka and President of Sri Lanka Baseball Association was appointed as Director of West Asia Baseball for the Baseball Federation of Asia.

3. TASKS

3.1 Jointly Meeting with IOC / NOC Sri Lanka / Ministry of Sports on Olympic Movement of NOC Sri Lanka – Sport Law & Regulations

The meeting on the Olympic Movement of NOC Sri Lanka, Sports Law & Regulations between International Olympic Committee / NOC Sri Lanka and Ministry of Sports was held at the IOC Headquarters in Lausanne, Switzerland on 4th June 2019.

The delegation from NOC Sri Lanka comprised of Mr. Suresh Subramaniam, President of NOC Sri Lanka, Mr. Maxwell de Silva, Secretary General of NOC Sri Lanka and Mr. Dilshan Jayasooriya, the legal consultant. The delegation from Ministry of Sports comprised of Secretary, Mr. Chulananda Perera, Mr. Panduka Keerthinanda and few other officials. Hon. Hareen Fernando, the Sports Minister at the time had joined the meeting via skype. It was brought to attention that Mr. Sumathi Dharmawardhana of AG's Department was not accompanied by the Ministry of Sports.

The IOC informed of working on the road map which already been given five years prior; they assured that necessary initiatives will be taken. During this meeting, it was communicated that Interim Committees and illegal sports organizations such as AFSF will not be recognized by the IOC.

3.2 100 million allocated by the Government for the development of Sports and Prime Minister's Sports Fund allocation of LKR 46.0 Mn

During the reign of former Prime Minister Hon. Ranil Wickremasinghe, the NOC Sri Lanka was instrumental in launching PM's Sports Fund (unused money received for flood donation from private sector) during the Asian Games in 2018. To mark the occasion PM's office had a launching ceremony with all distinguished guests on 07/08/2018 at Temple Trees. Approximately LKR 46.0Mn was credited to Prime Ministers Sports Fund, subsequently to be transferred to the account of the NOC SL to utilize for Asian Games 2018 and high performance of athletes.

Thereafter, as a result of an appeal to the former Hon Finance Minister, Mangala Samaraweera MP, the NOC Sri Lanka was allocated through the national budget the parliament allocated LKR 100.0Mn; to be used solely for the development of the sports of the 33 national sports associations, registered under the NOC Sri Lanka and for the welfare of talented athletes leaving schools for few years (two or three years) through the High-Performance Committee until they reach the national level; most talented young athletes join various jobs that prevent the trainings and sport career.

In this connection, a "Trust Fund" was created with distinguished personalities namely; Mr. Mahela Jayawardena, Mr. Suresh Subramaniam, Mr. Mahesh Hirdaramani, Mr. Maxwell de Silva and Mrs. Caryll Tozer being members of it.

However, the funds were not distributed to NOC Sri Lanka owing to the changes in government.

3.3 Medical Panel

On the recommendation of the Chair of the Medical Committee, Maj. Gen. (Rtd) Dr. C. Thurairaja, a Medical Panel was established under the Medical Committee of NOC / CGA Sri Lanka.

3.4 Committee for National Colours

A Committee was appointed to publish a policy for National Colours under the opinion and direction of the Immediate Past President, Mr. Hemasiri Fernando. The Committee consisted of Maj. Gen. (Rtd) Dr. C. Thurairaja as the Chair, and Mr. Ajith Kuruppu and Mr. Mahela Jayawardena as members.

3.5 Committee for Recommendation of Payment for EB members of NOC/ CGA Sri Lanka

A Committee was appointed to recommend criteria of payment / allowance for President and Secretary General and members of the Executive Board (elected and by invitation) for attending local meetings, day to day work and overseas travelling representing NOC Sri Lanka in the absence of President and/or Secretary General. The Committee comprised of Maj. Gen. (Rtd) Dampath Fernando (as Chair of the Committee), Mr. Gamini Jayasinghe (member) and Mr. Nishantha Jayasinghe (member).

3.6 Signing of MOUs

a. Strategic Partner for Inter School E-sport Championship 2019

The NOC / CGA Sri Lanka endorsed the Inter-School Programme conducted by the E-Sport Association of Sri Lanka and agreed to be the Strategic Partner for the Inter-School E-sport Championship 2019. The purpose was to benefit NOC Sri Lanka through sponsorship/revenue gained in working with the E-Sport Association for the South Asian Games E-Sport Festival.

3.7 Pirith Ceremony of NOC / CGA Sri Lanka

The Pirith Ceremony to bless the athletes and officials was successfully held on the 11th and 12th January 2019 at the Premises of NOC / CGA Sri Lanka. Mr. Sarath Kuragama of Yachting Association of Sri Lanka and the Secretary of All Ceylon Buddhist Congress coordinated with the Temples for the arrangements of the Ceremony. The night-long ceremony was performed by Buddhist monks on 11th January 2019. The Pirith Ceremony was attended by officials of NFs, athletes, and the Secretary and other officials from the Ministry of Sports.

3.8 Sustainability in Sport | Environmental Sustainability Programme Beach Cleaning, Coral Replantation, and Preservation | 25.06.2019 - 31.12.2020

For the first time in the history of NOC Sri Lanka, the Committee commenced a new project under environmental sustainability to replant and preserve corals. The initiative was launched together with Olympic Day Celebrations on 25th June 2019.

Stakeholders of the initiative were Marine Environment Protection Authority of Sri Lanka (MEPA), Tokyo Cement, The national Aquatic Resources and Development Agency (NARA), Sri Lanka Coast Guard, Department of Coast Conservation and Coastal Resources Management, Ocean Resources Conservation Association, Sri Lanka Navy, Amaloh Beach Boutique Resort, Polhena Reef Gardens Hotel and Sirasa TV.



Under this initiative an art competition, beach cleaning, beach sport activities (swimming, surfing, beach volleyball, beach kabaddi, lifesaving), and a presentation by MEPA on corals were conducted.

Prior to the event, the students of all schools in the Matara District were invited for an art competition under the theme 'Give the Reef Another Chance' by the Educational Department. More than 2500 colourful and expressive paintings were received and 70 of these were selected.

3.11.3 EB Meeting of SAOC and Chef-de-Mission Meeting

The EB meeting of the SAOC and the Chefs de Mission meeting were held on 9th and 10th November 2019 in Kathmandu regarding the South Asian Games. The EB meeting was attended by Secretary General, Mr. Maxwell de Silva and Mr. Asanga Seneviratna, Vice President (on behalf of President). The Chef-de-Mission meeting was attended by Maj. Gen. (Rtd) Dampath Fernando and Mr. Gamini Jayaisnghe. The Director General of Sports, Mr. Dammika Muthugala and the Director of Sports Mr. I.P Wijerathne attended the Chefs-de-Mission meeting on invitation as observers. During the meetings, the delegation visited the proposed venues of the South Asian Games.

3.11.4 Refresher Course

The NOC Sri Lanka made the Sport Administrators Course mandatory for the officials taking part in the South Asian Games. A refresher course was held on 20th and 21st November 2019 and was specifically designed for officials who had been unable to follow either of the three Sport Administrators Courses held by the NOC during the year. A group of 12 officials comprising 8 males and 4 females successfully completed the course. The National Course Directors, Mr. B.L.H. Perera, Gp. Capt. (rtd) Nalin de Silva and Ms. Olivia Gamage and Resource Personnel, Dr. Shiromi Pilapitiya were the speakers.

3.11.7 Ordinary Level Examination in Kathmandu

Upon the request of parents and athletes, the NOC Sri Lanka made necessary arrangements together with the Department of Education / Department of Examination, Ministry of Sports and the Embassy of Sri Lanka in Kathmandu to conduct the General Certificate of Education Ordinary Level (G.C.E. O/L) at an examination centre in Kathmandu. 6 athletes in 5 sports; i.e., fencing, squash, table tennis and tennis, sat for the O/L at the Kathmandu Examination Centre under the supervision of officials from the Department of Education. The Organising Committee of the Nepal Games also assisted immensely in making this effort a success.

At the 13th South Asian Games Sri Lanka won 249 medals of which 40 were Gold, 81 were Silver and 128 were Bronze. Sri Lanka placed 3rd in the overall medal table.

3.7 Olympic Games – Tokyo 2020

3.7.1. Chefs-de-Mission Seminar

The Chefs-de-Mission (CDM) seminar ‘Tokyo 2020’ was held from 20th to 22nd August 2019 at the Hotel New Otani in Tokyo; the Assistant Secretary, Wg. Cdr. (Rtd) Chandana Liyanage and the Secretary General Mr. Maxwell Silva attended the seminar. The two delegates had a successful meeting with officials from the Embassy of Sri Lanka in Japan, Mayor of Hashima city and Sammu, Maebashi and Gunma. Sammu city had agreed to host a 10-day training camp for our athletes before the games and Hashima city had agreed to organize a tour for the Sri Lanka delegation, including Para-Olympic athletes, after the Tokyo 2020.

3.7.2. Press by Number

3.7.4. Qualification of Athletes

a. Tripartite Commission Invitation Places

The International Olympic Committee informed that Sri Lanka was eligible to enter the Tripartite Commission Invitation places. Accordingly, applications were called from the eligible NFs to nominate athletes who met the minimum eligibility standards for Invitation places according to International Federations. The nominations received from archery, badminton, gymnastics, judo, weightlifting and shooting were sent to IOC – Olympic Solidarity.

b. Equestrian qualification of Mathilda Karlsson and Removal of Longines Ranking Competitions at Villeneuve-Loubet

The Equestrian athlete, Mathilda Karlsson was 2nd in Group 'G' which was more likely to qualify for Tokyo 2020. However, with the removal of the event she was disqualified, and Sri Lanka missed an opportunity to represent Equestrians at the Olympics.

c. Assistance for Participation in Olympic Qualification Tournament - 49th FIG Artistic Gymnastics World Championships – Stuttgart (Germany)

The 49th FIG Artistic Gymnastics World Championships which was an Olympic qualification tournament was held in Stuttgart, Germany from 04th to 13th October 2019. The Artistic Gymnast, Milka Gehani who was undergoing training in Japan under the auspices of IOC – OS, requested financial assistance for herself and her coach – Mr. Ranjana Tharanga in order to take part in the Championship. Accordingly, the NOC Sri Lanka assisted them to cover their accommodation charges in Germany and a sum of Rs. 841,172.70 was spent in this regard.

3.8. 2019 Macau Galaxy Entertainment 38th International Marathon

The 2019 Macau Galaxy Entertainment 38th International Marathon jointly organized by Macau Sport Bureau and the General Association of Athletics of Macau was held on the 1st of December 2019. As per the recommendation by the Sri Lanka Athletics Association, the following athletes took part in the event.

3.10. Training for Rumeshika Rathnayake in USA

Female Sprinter, Rumeshika Ratnayaka attended a training in the U.S. However, owing to unfortunate circumstances, she was under custody on 19th March 2019, the day she was to leave the country. She was stopped at airport immigration on the instructions issued by Maj. Gen. Sudath Perera, Vice President of AASL and Chairman of Sri Lanka Army Athletics. Maj. Gen. (Rtd) Palitha Fernando, President of AASL and Vice President at

NOC Sri Lanka, stated the athlete was a deserter from the SL Army and must be arrested at her daily training venue. Rumeshika was stopped by Airport police for over 12 hours, but according to the Chair of the House, the letter had been sent two-day prior Rumeshika's departure. Thus, the AASL had ample time to notify the athlete or the NOC about this matter and avoid harassing the athlete publicly and needlessly.

Nevertheless, the NOC Sri Lanka was able to send her for training at Altis World in Arizona, USA from 19th March to 20th April 2019.

3.11. Trainings in Slovenia for South Asian Games 2019 and Olympic Games, Tokyo 2020

Judoka, R. Chamara Nuwan Dharmawardhana underwent training in Slovenia from 22nd November to 5th December 2019 and thereafter recommenced training from 24th December 2019 onwards while targeting the South Asian Games 2019 in Kathmandu, Nepal and the Olympic Games, Tokyo 2020. At the South Asian Games Judoka, Chamara Dharmawardhana secured 1st place; Sri Lanka achieved only Gold in Judo. Chamara trained in Slovenia and

3.12. Visit of Mr. Tony Campbell

The High-Performance Committee of NOC Sri Lanka, on the recommendation of Ms. Susanthika Jayasinghe, Director of HPC, arranged workshops for athletes and for coaches on motivating athletes. Mr. Tonie Campbell visited Sri Lanka from 7th to 9th October 2019. After his short visit, he developed a report after having an interactive session with National level athletes, coaches, and officials and also inspecting some of the Athletics venues.

Two sessions - of which one morning session was conducted for athletes in Athletics at "Hemasiri Fernando Auditorium" and the other for all other NFs athletes and coaches at the Auditorium

9th October, Mr. Campbell has visited 3 athletics venues, Torrington, Sugathadasa and Diyagama stadiums and Ms. Susanthika overlooked the participation of athletes. Veteran journalist, Mr. Asoka Goonathilaka was assigned to be his interpreter during this short tour.

3.13. Assistance to National Federations

a. Annual Grant for the year 2019

21 NFs claimed the NOC / CGA Sri Lanka annual grant of Rs. 200,000/- for the year 2019.

b. The Cycling Federation was assisted by the NOC Sri Lanka by sponsoring for two economy class air tickets to attend Asian Cycling Championships 2019 in Tashkent.

- c. The Wrestling Federation of Sri Lanka was sponsored by one economy class air ticket to attend the Asian Wrestling Championship 2019 in China.
- d. Assistance to Sri Lanka Hockey Federation
 - i. The Sri Lanka Hockey Federation conducted a Programme for coaches and Umpires and the NOC Sri Lanka assisted them financially with a sum of Rs. 180,000/- to cover the cost for T-shirts.
 - ii. The Hockey Federation of Sri Lanka was donated a laptop by e-wise to NOC Sri Lanka.
 - iii. NOC Sri Lanka assisted the Hockey Day Run financially by donating Rs. 67,000/- to cover the cost for T- shirt Payment.

3.14. Track and Field Coaching Diploma from the German Athletics Association

The Embassy of the Federal Republic of Germany in Colombo was invited to nominate coaches for a top-level training and development program for Coaches in track and field offered by the International Academy for the Coaches of the German Athletics Association in Mainz. The two names received under the recommendation of the Athletics Association of Sri Lanka, i.e., Mr. Vimukthi de Zoysa and Maduka Marasinghe were sent to the Embassy.

3.15. OCA – Incheon Vision 2014 Programme

The OCA-Incheon Vision 2014 program invited the 2019 programme. The aim of the Programme was to narrow the gap in sport levels among Asian countries. After the successful conclusion of the 2014 Incheon Asian Games, Incheon Metropolitan City implemented ‘the OCA-Incheon Vision 2014 Program,’ and aimed at a balanced growth of Asian sports and an increase in exchange and cooperation with each nation’s NOC. Wrestling was nominated for the programme.

3.16. Team Support Grant

The IOC – Olympic Solidarity, under the Team Support Grant, offered a scholarship to Sri Lanka Rugby to cover training & preparation expenses (in Sri Lanka), and participation expenses and coaches’ expenses for the period 2017 to 2020, thereby approving a total budget of USD 60,000/-.

3.18. Technical Course for Coaches for 2019

Football, handball, judo and wrestling were allocated Technical Courses for the year 2019 under the auspices of IOC – OS. However, due to various circumstances none of the NFs were able to submit the applications.

3.19. Continental Athlete Support Grant

IOC – Olympic Solidarity approved a sum of USD 48,227/- under the Continental Athlete Support Grant for basketball, golf, handball and wushu for the year 2019.

3.20. International Coaching Course in 2019

The International Coaching Course for the year 2019 organized by the International Relations Directorate (*University of Physical Education*) in Budapest, Hungary was held from 18th March to 7th June 2019. Ms. H. Renu Chandrika de Silva of Badminton was selected for this programme and she was sponsored by IOC – Olympic Solidarity. Ms. Renu Chandrika successfully completed the course and had achieved an excellent mark of 4.6 points.

3.21. Programme of Olympic Scholarships for Coaches 2019 - Sport & Life Academy by Pancho Alvariño - La Eliana - Valencia (Spain) - Specific training in Tennis

Mr. Renouk Vasantha Wijemanne was invited by the International Tennis Federation to attend the training in Tennis delivered at the Sport & Life Academy by Pancho Alvariño in La Eliana – Valencia (Spain) from 3rd June to 14th July 2019; Mr. Wijemanne successfully completed the programme.

3.22. 12th Edition of the International Coaching Enrichment Certificate Programme (ICECP)

The applications were called for the International Coaching Enrichment Certificate Programme (ICECP) which was being conducted in conjunction with the United States

Olympic Committee and the International Olympic Committee – Olympic Solidarity. Only two applications were received by the deadline. However, as the IF recognized representatives of Sri Lanka Archery Association denied to issue a recommendation letter, Mr. Navindra Dayan who was the other candidate received the support of the NOC Sri Lanka for the ICECP and was awarded the scholarship from the IOC – OS. The programme involved 3 modules of which 2 were conducted during the year 2019. The online module was held from 15th August to 15th September 2019. The second module was held from 15th September to 12th October 2019 at the University of Delaware and at the U.S. Olympic Training Centre in Colorado Springs, Colorado. The third module was planned to be held from 26th April to 1st May 2020 in Lausanne, Switzerland.

Educational Programmes

3.23. Award Ceremony Advanced Sports Management Course – 2017/ 2018

The Award Ceremony of the ASMC 2017/2018 was held on 28th February 2019 at the 'Hemasiri Fernando' auditorium. 21 recipients, 7 of from NFs and others were from other institutes, were awarded. The Chief Guest was Mr. Nikhil Grero, the Director of the Lyceum International School and the Guest of Honour was Mr. Dhammadika Muthugala, Director General of Sports Development.

3.24. Olympic Solidarity Sport Administrators Course – 1st Session

Due to the uncertainty that followed the tragic Easter Sunday attack, the NOC Sri Lanka postponed the 1st session of its Olympic Solidarity Sport Administrators Course from 09th to 12th May 2019 and rescheduled it to be held from 23rd to 26th May 2019. Of the 80 applications, 50 were selected for the course, and of these 27 were male and 23 were female. The programme was conducted by the National Course Directors, Mr. B.L.H. Perera, Gp. Capt (rtd) Nalin de Silva and Ms. Olivia Gamage. Other resource personnel were Dr. Shiromi Pilapitiya, Dr. Rukmal Karunaratna and Mrs. Lalitha Mendis. At these sessions, the NOC Sri Lanka was able to interact with a segment representing primary stakeholders of sport in Sri Lanka, mainly NFs and NOC Sri Lanka elected and appointed personnel.

3.25. Olympic Solidarity Sport Administrators Course – 2nd Session

The 2nd session of the Sport Administrators Course for 2019 was held from 19th to 22nd September 2019. The selection of participants was done on 10th September at the Olympic House. Of the 55 applicants, 40 were present for the interview. The panel comprising Mr. B.L.H. Perera and Group Captain (rtd) Nalin de Silva selected all 40 (28 men & 12 women) for the 2nd Session of the Sport Administrators Course.

The 2nd SAC was largely conducted to attract secondary stakeholders of the sports community representing educational institutes, clubs, armed forces, and graduates in Sport Management, Sport Science and Physical Education. The course content was formulated using Sport Administration Manual (2014) and comprised the Olympic background, Olympic Values and impacts on governance, conflict management, leadership, and simple to semi-complex process tasks of organisational administration, harnessing sport talent and best practices.

The National Course Directors, Mr. B.L.H. Perera, Mr. Maxwell de Silva, Gp. Capt. (rtd) Nalin de Silva and Ms. Olivia Gamage conducted the course. Other resource personnel were Dr. Shiromi Pilapitiya, Dr. Rukmal Karunaratna and Mrs. Lalitha Mendis.

3.26. National Course Directors Programme – 2019

On the request of NOC Sri Lanka to finalise the National Course Directors (NCD), the IOC - OS nominated Ms. Moira Tan of Malaysia to conduct the programme. Ms. Tham Choy Lin assisted her during the programme. The NCD programme was held from 24th to 27th October 2019 (in conjunction with Sport Administrators Course – 2nd session) at the Olympic House. 14 participants (7 local and 7 foreign) attended the programme. 3.27. Olympic Solidarity Sport Administrators Course – 3rd course

The 3rd course was conducted under the special approval of the IOC – Olympic Solidarity especially targeting Sport Administrators participating in the South Asian Games as Managers/Coaches. It was conducted in conjunction with the National Course Directors programme. The 3rd course of the Sport Administrators Course 2019 was held from 24th to 27th October 2019. The programme benefitted 57 participants (53 males and 4 females) and the new version of the Sport Administration Manual (2018) was used for the very first time at these Courses. Some of its focal areas included the role of IOC and leadership, Olympic values and impacts on governance, conflict management, team leadership and management, tasks of organizational administration, and sport talent management during competition and in training. Issues related to overseas sport tours and managing athletes were also discussed. The objective of this special segment was to educate the team officials and uplift each one to an established standard. Thereby, NOC Sri Lanka encouraged all

team officials of Affiliated and Non Affiliated sports federations of Sri Lanka to follow this course.

The National Course Directors, Mr. B.L.H. Perera, Mr. Maxwell de Silva, Gp. Capt. (rtd) Nalin de Silva and Ms. Olivia Gamage conducted the course. Other resource personnel were Dr. Shiromi Pilapitiya, Dr. Rukmal Karunaratna and Mrs. Lalitha Mendis.

3.28. 16th National Olympic Academy with the participation of South Asian region NOCs



The programme was held in Diyathalawa Army Camp from 23rd to 26th November 2019 and the Programme Director was Mrs. (Dr) Samantha Nanayakkara. There were 57 Participants of which 39 (21 men & 18 females) were from universities, 11 (6 men & 5 females) were from National Federations and 6 (3 men & 3 females) were from Maldives Olympic Committee. The IOC – OS funded USD 8,561.00 for the programme. The other lecturers of the programme were Mrs. Hemanthi Ranasinghe of University of Sri Jayawardanapura, Ms. N.M.L. Radhika and Mr. Ranjan Dharmawardane of Central Environment Authority of Sri Lanka.

3.29. IOC – OS PD Candidature Programme

Mr. S. Gobinath was recommended by the NOC Sri Lanka to IOC – Olympic Solidarity to be trained as a Programme Director, as a potential stand-in for Mr. B.L.H. Perera.

3.30. Sports Medicine and Protection of Clean Athletes - IOC World Conference on Prevention of Injury and Illness | 12.03.2020 - 14.03.2020

The applicant Mr. Malitha Sahabandu was accepted by the IOC – OS for the IOC World Conference on Prevention of Injury and Illness which was planned to occur from 12th to 14th March 2020. 4 applications were received: Akhila Imantha Nilaweera, Dr. Asela Ratnayake, Dr. Himan de Silva and Mr. Malitha Udara Sahabandu. And upon the recommendations of the President and Executive Board of NOC Sri Lanka, Mr. Malitha Sahabandu was nominated to IOC – Olympic Solidarity for the sponsorship.

3.31. Advance Sport Management Course 2019/2020

The IOC – Olympic Solidarity approved the application of NOC Sri Lanka to conduct the 7th edition of the Advance Sport Management Course for 2019/2020. The IOC approved a budget for USD 14,000 per course with a 60/40 gender balance (participation of minimum

40% women sports administrators). An advance of 75% of USD 10,500/- had already been received.

A workshop was conducted by the Programme Director, Prof. B.L.H. Perera on 31st of July 2019 and 31 applicants were selected for the programme. The programme was designed with seven modules of which three modules were to be conducted in 2019 and the rest to be completed in 2020.

Session one – 17th & 18th August 2019

The 1st module of the ASMC 19/20 was held on 17th and 18th August 2019 at the ‘Hemasiri Fernando’ Auditorium of NOC Sri Lanka by the Programme Director, Mr. B.L.H. Perera and it was attended by 20 participants of the 31 participants who were selected for the course.

Session two – 19th & 20th October 2019

ASMC Session 2 was held on 19th and 20th October, 2019 at “Olympic House”. Day 1 was allocated for participants’ presentations of the MOSO Chapter 1. Day 2 was allocated for MOSO Chapter 2 ' Managing Strategically'. The course was conducted by Programme Director Mr. B.L.H. Perera.

Session three – 21st & 22nd December 2019

3rd Session of the 7th ASMC was held at the *Laya Leisure Kukuleganga* on 21st & 22nd December 2019.

The other four sessions were planned to be set in 2020.

3.32. Educational Programmes conducted by the International Olympic Academy (IOA)

a. 15th Joint International Session for Presidents or Directors of National Olympic Academies (NOAs)

The 15th Joint International Session for the Presidents or Directors of NOAs was held from 10th May to 17th May 2019 and upon the recommendation of the Education Committee, Ms. Anoma Rathnayake, a Provisional Course Director, attended the Course.

b. 59th International Session for Young Participants

As the IOA and IOC – OS discussed and agreed with, the NOC Sri Lanka made necessary arrangements for the Winners of the OVEP 2017 and one accompanying person to visit the Olympia during the 59th International Session for Young Participants held from 1st to 15th June 219 in Greece.

They were to be accompanied by Mr. B.L.H. Perera who was well aware of the area and possessed vast knowledge on Olympism. However, due to a technical error in the visa process by VFS, Mr. B.L.H. Perera and Sarah Perera could not travel to Greece as planned. Instead, Gp. Capt. (rtd) Nalin De Silva accompanied the three children. During the session the three winners of the OVEP 2017 debate delivered a presentation to the participants of the session.

c. Master's Degree Programme 2019 / 2020

Mr. K.D.S. Wimalasena, a graduate from the University of Colombo (2015 – 2018) and a Volleyball athlete, was selected for the Master's Degree Programme 2019/2020 "Olympic Studies, Olympic Education, Organisation and Management of Olympic Events" under the recommendation of the Sri Lanka Volleyball Federation. He was sponsored by the IOC – Olympic Solidarity with his course fees which was to be directly paid to IOA / the University of Peloponnese. The programme was held across 3 semesters of which two semesters consisted of lectures and the other facilitated the preparation of the master's thesis. The 1st semester was held from 12th September to 16th November 2019 in Olympia, Greece. The 2nd Semester was expected to continue from 27th April to 4th June 2020 in Olympia, Greece.

3.45 Dream Together Master" at Seoul National University – August 2019 to June 2021

The NOC Sri Lanka received applications for the Dream Together Master programme 2019 / 2021 at Seoul National University. Ms. Anoma Rathnayake, Ms. Harini Dilshani, Mr. S. Gobinath and Ms. Hansika Wijayagunasekara were benefitted by this programme from Sri Lanka. Ms. Deepika Wahigaldeniya had been selected by the organisers for the 2019/2021 period and she was fully sponsored by the University.

3.46 Olympic Day Celebrations - 2019

For the first time in NOC Sri Lanka history the Olympic Day Celebrations were held introducing some sports and combining another project under IOC – Olympic Solidarity environment sustainable project.

a. Press Conference

A Press Conference on the Olympic Day Celebrations and Coral Replantation was held on 13th June 2019 at 3.00 p.m. at the "Hemasiri Fernando Auditorium".

b. Run and other activities

The Olympic Day Celebrations were successfully held on 25th of June 2019 in Polhena. The 'Run' of 4 km distance from Polhena beach to Uyanwatta stadium with the participation of nearly 1000 school children from 18 schools in Matara District was held together with OVEP art presentation with the participation of 21 schools in Matara District.

Parallel to the Olympic Day Celebrations, a special project on coral replantation was held on the same day.



Mr. B.L.H. Perera was in charge of the education of the OVEP and OVEP art presentation. Maj. Gen. (Rtd) Dampath Fernando and Senior DIG (rtd) Sumith Edirisinghe was in charge of security arrangement. Mr. Gамиni Jayasinghe and Wg. Cdr. (rtd) Chandana Liyanage was in charge of other logistic arrangements in both Olympic Day Celebrations and Coral replantation project.
